

LEGAL NOTICE TO BIDDERS

Sealed bids will be received at Council Chambers, located at 515 E. Main Street, Van Wert, Ohio 45891 until **11 a.m. (local time) on Tuesday, March 6, 2012** for furnishing all labor, materials and equipment necessary to complete the Project known as **CITY OF VAN WERT, VAN-WALL ST. (00.11)(00.24), VAN WERT, OHIO** at which time they will be opened and publicly read.

The proposed work consists of approximately 654 lf of roadway reconstruction with concrete curb, drainage, asphalt pavement, etc.; 223 lf of sanitary work; 173 lf of waterline work including 73 lf of casing under railroad and all other appurtenant work complete with all related items as shown on the Construction Drawings and called for on the Form of Proposal.

Bids will be accepted only from Contractors who are prequalified for this type of work with the State of Ohio, Department of Transportation, per Section 102.01 of the State of Ohio, Department of Transportation, Construction and Material Specifications, dated January 1, 2010.

Copies of the Construction Drawings, Specifications and other Contract Documents may be obtained or examined at the office of Kohli & Kaliher Associates, Inc., 2244 Baton Rouge Avenue, Lima, Ohio 45805.

A non-refundable payment of **eighty (\$80.00) dollars** will be required for each set of Drawings, Specifications and Contract Documents taken from the above office. Checks shall be made payable to **Kohli & Kaliher Associates, Inc.**

Each bid shall contain the full name of each person or company interested and shall be accompanied by a Bid Guaranty Bond and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code, or certified check made payable to the City of Van Wert, equal to at least ten (10%) percent of the bid upon the condition that if the bid is accepted, a contract will be entered into within ten (10) days. A performance bond of one hundred (100%) percent of the amount of the contract, with satisfactory corporate sureties, will be required for the faithful performance of the work. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Bidders must comply with the prevailing wage rates on Public Improvements in City of Van Wert, Van Wert County, Ohio as determined by the Ohio Department of Commerce.

Bids shall be sealed and endorsed **CITY OF VAN WERT, VAN-WALL ST. (00.11)(00.24), VAN WERT, OHIO.**


No proposal will be entertained unless made on the blanks attached to the bound documents furnished by the City and designated for taking bids for this Project.
